PROGRAM

This course aims to provide students with discussions on economic and social development. Emphasis is given to historical analysis of capitalism and transformations in the global economy.

As part of the GLU program, this course is entirely taught in English. It is expected that all enrolled students be able to read and understand in this language.

Course assessment consists of:

- Presentation and final paper on students' countries (or a country of their choice) in two sessions
